Warren Groseclose '83 – CEO, Lawrence Companies

Warren is a 1983 Graduate of the Virginia Military Institute with a BA in Economics. After a brief 6 months as a Congressional intern, he entered the Army as an Armor Officer in Fort Knox, KY, was accepted into flight school and served a total of six and a half years on active duty. As an Army aviator, he was selected to be a company commander as a first lieutenant and accumulated over 800 hours of accident-free flying while serving in the Federal Republic of Germany prior to the fall of the Berlin Wall.

Warren started his "land" transportation career in 1990 with Tidewater Transit Company out of Kinston NC. He began in a general management position for the family-owned tank truck company when it had 76 trucks and he rose to become the Executive Vice President. Warren's primary duties were in operations and sales that helped expand this family-run business from 3 terminal locations in NC to 14 terminals in 8 states and by 2005 they had grown to over 330 trucks. In addition to helping expand Tidewater Transit's customer base, he also was awarded a patent while working on a customer project with Amoco Chemical in Naperville, Illinois. The patent, "Use of Inert Gas in Transfer of Commuted Product to Tank" totally changed Amoco's distribution system for a dry bulk material used in the production for plastic resins. Warren then moved to Richmond, VA in 2005 to go to work for Atlantic Bulk Carrier Corporation (ABC) as their VP of Operations and Sales. He was with ABC for 13 years and helped grow their business from \$16 million to \$40 million in sales. In 2018 he accepted a position with Hillcrest Transportation as their COO. Hillcrest is another family-owned tank truck company out of Petersburg, VA and in 3 short years Warren expanded their business primarily from Virginia into Decatur, AL and Pensacola, FL establishing Hillcrest's second largest customer, Ascend Performance Materials.

In 2021 Warren moved to Roanoke to work for Lawrence Companies and became their CEO in January of this year. Lawrence Companies started in 1932 in the moving and storage business and is the oldest United Van Lines agent in the country. Lawrence Companies is in its 90th year of operation and has grown to 8 business divisions with 9 locations in Virginia and North Carolina and has been 100% employee owned since 2004. Lawrence Companies additional businesses include truckload and flat bed freight, Case Construction Equipment, Roll Off Container Services, Custom Truck Upfitting, Warehousing and Logistics.

Warren has served on the National Tank Truck Carriers Finance Committee, served as Finance Committee Chairman for Queen Street UMC in Kinston, NC and Reveille UMC in Richmond, VA. He currently serves on the board of the Virginia Trucking Association and Lanford Brothers Construction. Warren is active in the Boys and Girls Club of SW Virginia and hosts the Highland County Mountain Adventure for this group on his 300 acre ranch on an annual basis.

Bryce Valentine '91 – President and CEO, Imperial Holding, LLC

Bryce T. Valentine was born in Norfolk, Virginia, on 20 October 1965 and was raised in Norfolk and Virginia Beach. He spent his early elementary school years at St. Mary's Catholic, in Norfolk, before attending Cape Henry Collegiate, in Virginia Beach. Bryce then briefly attended New Mexico Military Institute, in Roswell, NM, where he played varsity tight end for the Bronco's and rode guide-on in their cavalry troop. After an equestrian accident that shattered his knee, Bryce returned home to recuperate in Virginia Beach, where he then graduated from First Colonial High School, in 1983.

In August 1983, Bryce began his Rat Year at the Virginia Military Institute with the Class of 1987. In 1984 he transferred to VPI, where he continued his studies in English and History. In August of 1987, Bryce began his Rat Year with the Class of 1991.

In 1991, Bryce went full-time at the groundbreaking leader in American Black-owned companies, founded in 1970 by his father, Herman E. Valentine, Sr.: Systems Management American Corporation ("SMA"). His father, a two-time Presidential awardee of the Minority Businessman of the Year, had led SMA to become a top-10 minority owned enterprise, with over 800 employees nationwide, headquartered in Norfolk, VA, in a building that was the largest real estate acquisition by a Black man in the history of the Commonwealth at the time his father had purchased it. SMA had focused on information technology systems integration and communications work, landing many major contracts with government entities such as the US Navy and Federal Aviation Administration as well as with major corporations such as Rockwell and IBM. The end users of SMA's expertise ranged from sailors aboard vessels in the Atlantic Fleet to astronauts aboard the Space Station Freedom.

By 1992, Bryce was serving as SMA's VP of Strategic Planning. That same year, he became the Director of the company's nascent Telecommunications Division ("SMA Telcom"), wherein he oversaw the strategic rollout of 800 MHz trunked radio systems across multiple state markets, with a variety of government clients (such as the City of Cleveland) and corporate partners (such as Motorola). SMA Telcom furthermore became an early player in the Phase I rollout of private sector CDMA and TDMA communications infrastructure, nationwide – working with companies such as Sprint, Ameritech and AT&T Wireless.

In 1995 Bryce married his wife of 27 years, Suzette Valentine (nee Martinez). Suzette is currently the Senior Vice President of Integration and Innovation for Molina Healthcare (NYSE: MOH). Their daughter and oldest child, Natalie, is a graduate of George Mason University and currently works for Congressman Bobbie Scott. Their eldest son, Joshua, will graduate from George Mason University in 2023 with plans for a career in social work. Their youngest child is Justin, who will receive his Associate Degree in 2023 and plans to complete a bachelor's degree at George Mason University.

Over the course of thirty years, Bryce has been passionately involved with local and regional theatrical productions. While excelling on-stage, he has acquired critical knowledge in many back-stage facets of theatre, ranging from performances, lighting, sound, set design and direction of original plays. Bryce has further utilized

this skill set to research and direct a series of Virginia history based short videos for release on streaming platforms in 2023.

In July of 2021 Bryce organized a Virginia LLC, named "Imperial Holding." His ambitions for this business entity are three-fold.

Firstly, the firm is a commercial enterprise, providing program/project management services to private sector and government sector clients, primarily in the areas of wireless communications and wind-based energy infrastructures. In this arena, Bryce and his team bring both proven and winning skill sets, as well as the value-added component of being a federal, state and municipally registered disadvantaged-minority business.

The second leg of Imperial Holding, LLC is to be operated from a 501(c)(3) subsidiary with the intentions of establishing and operating a college/university-based STEM initiative to focus on training college students, career professionals and VMI alumni in the principles of construction engineering as they pertain to the renewable energy sector and telecommunications industry.

A third leg is planned to produce history-based film and audio content, made via partnerships with federal, state, and municipal entities (such as the National Park Service and the Virginia Governor's Office), as well as colleges and universities (such as the Virginia Military Institute). We will also look to introduce positive and affirming media content, seeking to highlight select stories and biographies from American history. A handful of such projects are already in pre-production.

Lt. Col. Quintin Elliot, VAANG (Ret.) '85 – Former Chief Deputy Commissioner, Virginia Department of Transportation

Quintin D. Elliott was appointed Deputy Secretary of Transportation by the Governor of Virginia in January 2018. The Secretariat is responsible for the oversight of seven state agencies that included; the Virginia Department of Transportation, DMV, Virginia Port Authority, Department of Rail and Public Transportation,

The Space Port, Motor Vehicle Dealer Board and Aviation. Prior to this he was appointed as the Chief Deputy Commissioner of the Virginia Department of Transportation (VDOT) by Gov. Terry McAuliffe in January, 2014. Serving as the number two person that oversaw 7,800 employees and a budget of \$5.6 billion.

Quintin was with VDOT for 32 years serving as the District Administrator for six years in the Fredericksburg District and one year in the Culpeper District. As District Administrator he was responsible for all transportation related matters in a 14-county area that included highway construction, maintenance, land development, budget oversight, personnel management, public relations and coordination with state and local elected officials.

He held the position of VDOT's state maintenance engineer from 2002-2007 responsible for setting the direction and budget for the maintenance of Virginia's roadways. In that role, he managed the states \$1 billion highway maintenance budget and directed the maintenance of Virginia's 58,000 miles of state highways, bridges, tunnels and the equipment used to maintain them.

After graduating from college and starting his VDOT career as a transportation engineer trainee in 1985, he served as assistant resident engineer in the agency's Franklin and Williamsburg residencies. He was the Williamsburg resident engineer between 1991 and 2001.

Quintin holds a bachelor's degree in civil engineering from the Virginia Military Institute.

In addition to his transportation career Quintin served in the Virginia Air National Guard. He retired, as a Lieutenant Colonel, in 2008 as Commander of the 192 Civil Engineering Squadron and prior to that he served in the 203 Red Horse Squadron as Commander of the Heavy Equipment Flight. During one of his many active-duty deployments he led a team in the construction of a two-mile taxiway in Oman and eventual was asked to serve as the base commander for the entire base. He earned several awards and decorations for his military service, most notably the Meritorious Service Medal for his service during Operation Iraqi Freedom. Originally from Natural Bridge Virginia, Quintin is married to the former Emily Simmons of Windsor Virginia, and has a son Quintin Jr. and a daughter Emma.

Patrick Griffin graduated from the Virginia Military Institute in 1980, he entered the Navy and served on active duty until 1983. He served as a Surface Line Officer. When Mr. Griffin left active duty, he entered the Naval Reserve. Mr. Griffin retired from the Naval Reserve as a Commander.

He began his career with the Occupational Safety and Health Administration (OSHA) in May 1987 at the OSHA office in Waltham, Massachusetts as a Compliance Officer.
