Terms and Conditions

Welcome to the VMI Alumni Agencies web site. VMI Alumni Agencies licenses this online community from iModules Software, Inc. By using this site, you are agreeing to the following Terms and Conditions and the Privacy Policy concerning use of this Site. Please read them carefully. These Terms and Conditions and Privacy Policy may be revised from time to time by updating this posting.

1. Acceptance of Terms

This online community (referred to as "the Site") is provided as a service to you subject to your review and acceptance of the following terms and conditions of service.

2. Your Registration Obligations
